How Fake Consultancies Exploit Students

1. **Admission Fraud** – They claim to have “management quota” or “direct admission” access and take money without providing a valid seat.
2. **Fake Placements** – They promise jobs in top companies, take money for “processing fees,” and later give fake offer letters or ghost the students.
3. **Overseas Education Scam** – They promise easy admission to foreign universities and take money for visa processing, only to provide fake documents or vanish.
4. **Internship & Training Scam** – They lure students with internship offers, take money, and either disappear or provide low-quality, irrelevant training.

How to Identify Fake Consultancies

- **No Proper Office** – They avoid giving a permanent office address.
- **No Verified Track Record** – No credible student testimonials or proof of past success.
- **Upfront Payment Demands** – They ask for huge amounts before any admission or placement.
- **Fake Promises** – “100% job guarantee” or “Direct admission without exams.”
- **No Legal Registration** – Not registered under UGC, AICTE, or any legal body.
